

YOUTH SWINE SHOW-DEPARTMENT (YSS)

1. **ELIGIBILITY:** Exhibitor must be 8 years old by September 1, 2009. Exhibitor must be a current member of Osceola County 4-H or FFA, and may enter all open class shows.
 2. **ANIMAL ELIGIBILITY:** All swine must be at least 6 months of age by show time. Maximum weight limit is 350 lbs. No Boars will be allowed. Animals that cannot be handled properly will be disqualified and asked to be removed from the Fair Grounds. All swine must go to slaughter from the fair.
 3. **HEALTH REQUIREMENTS:** All animals will be required to meet the guidelines set by the State of Florida, Department of Agriculture. Hogs must arrive to fair, show ready and in clean trailers.
 4. **JUDGING:** Exhibitors must be present during judging or prior arrangements must be made with the committee, otherwise no premiums will be paid.
 5. **DRESS CODE:** Blue or Black jeans, White collared shirt or Club T-shirts tucked in, boots or brogans.
 6. **AC/HEAT:** There is no AC or Heat.
 7. **REGISTRATION:** All animals must be registered on Registration Day.
 8. **ANIMAL CARE:** Exhibitors will be required to feed and water their own animals and bring their own feed. All animals must be cared for by the exhibitor. This includes feeding, watering, and cleaning pens. Exhibitors will need to bring feed each day for their animals. Please clean out pens when checking out. Remember these exhibits are for the public to view, let's show them something we're proud of. Clean animals and clean pens.
 9. **HANDLING:** No animal will be exhibited in competition that cannot be properly led and handled by the exhibitor. Animals that cannot be handled properly will be disqualified and premiums forfeited.
 10. **CHECK OUT:** Exhibits removed before check-out time and date will result in forfeiture of premium money.
 11. **PREMIUMS:** All premiums will be mailed to the exhibitors after the fair. Please allow up to 6 weeks.
- **Your animal area must be clean (inside/around) at all times, including checkout time. If not clean, premiums will be forfeited.**

SWINE RULES AND REGULATIONS

1. **Entries Allowed:** Two (2) Swine. Animal must be registered on Registration Day (with the exception of market hogs not making weight).
2. **Mandatory Meeting:** A mandatory meeting will be held the day of check-in right after check is complete on Thursday, February 11, 2010 at 5 pm in the show arena.
3. **Premiums:** Placings: 1st - \$8.00 2nd - \$5.00 3rd - \$3.00 4th -10th - \$2
Grand Champion - \$75.00 Reserve Champion - \$50.00
